

Financial Support Guidance 2022/2023

There are 3 types of financial support available at Orchard Hill College which help remove financial barriers to learning. These are:

- 1. 16 – 19 Vulnerable Bursary – Maximum of £1,200**
- 2. Discretionary Bursary – To help with transport, meals, books and equipment**
- 3. Free College Meals – Money for College Meals (£3.50)**

Are you:

- Aged 16 and over, on a funded course at Orchard Hill College (please be aware some bursaries may have a higher age limit)
- A resident in the UK or EEA and have been for 3 years prior to 31 August 2022
- Able to meet the eligibility criteria – overleaf

Then you are eligible to apply.

What happens next?

- Complete and return the application form with the relevant evidence
- If you are eligible for one of the 3 bursaries, you will receive a written confirmation from the college
- You will receive your bursary every 2 weeks in accordance with your attendance and behaviour
- Please be advised, you will not be paid for the days you do not attend college

ELIGIBILITY CRITERIA

If you are:

- In care
- Leaving care
- Receiving Employment and Support Allowance (or Universal Credit) and in receipt of Disability Living Allowance or Personal Independence Payments – in the student's name
- Receiving Income Support – in the student's name
- Applicant will need to be under the age of 19 as from the 31st August

You will be eligible for the 16 – 19 Vulnerable Bursary.

If you are:

- Receiving Income Support – in the student's or parent's name
- Receiving Universal Credit (earnings not exceeding the equivalent of £7,400pa for School Meals) – in the student's or parent's name
- Receiving Job Seekers Allowance – in the student's or parent's name
- Receiving Employment Support Allowance – in the student's or parent's name
- Receiving Support under Part VI of the Immigration and Asylum Act 1999
- In receipt of Child Tax Credit (only if you are not entitled to working tax credit) and have an annual gross income of £28,000 or less
- Working Tax Credit run-on (paid for 4 weeks after you stop qualifying for Working Tax Credit)
- The guarantee element of State Pension Credit
- On a low household income (under £28,000)
- In need of extreme financial help (Exceptional Circumstances)

You will be eligible for the Discretionary Bursary.

If you are receiving:

- Income Support – in the student's or parent's name
- Universal Credit (earnings not exceeding the equivalent of £7,400pa for School Meals) – in the student's or parent's name
- Job Seekers Allowance— in the student's or parent's name
- Employment Support Allowance - in the student's or parent's name
- Support under Part VI of the Immigration and Asylum Act 1999
- Child Tax Credit (only if you are not entitled to working tax credit) and have an annual gross income of £28,000 or less
- Working Tax Credit run-on (paid for 4 weeks after you stop qualifying for Working Tax Credit)
- The guarantee element of State Pension Credit

You will be eligible for Free College Meals.

All evidence must be dated within 12 months of date of application.

ORCHARD HILL COLLEGE PAYMENT

- Lunches (including Free College Meals) – £3.50 per day.
- Discretionary Bursary (Travel) – Dependent on costs of travel. We expect you to use to cheapest form of travel available.)
- Discretionary Bursary (Equipment) – Dependent on the educational/training equipment and support requested. The college may only make a contribution. Receipts will be required for all purchases.
- Additional Support – Dependent on the level of support required, the college may supply a voucher or purchase items on your behalf: Stationery, IT Consumables, Clothing, Footwear, Hygiene Products and Sports/Wellbeing Activities.

Please Note: Payment total will be subject to funding allocation availability and the number of applicants in 22/23. An additional support request form will need to be completed and in order for OHC to consider additional support you may be asked to provide details of the number of people in your household and the total income for your household.

OTHER DISCOUNTS AVAILABLE

Freedom Passes

- A Freedom Pass is provided by local borough councils to give disabled Londoners free travel on almost all public transport in London.
- If you live in London and are disabled, you could be entitled to a Freedom Pass.

18+ Student Oyster Cards

- The scheme allows you to get 30% off the price of adult rate Travelcards and Bus & Tram Pass season tickets if you live within greater London.
